General

- a) Appointments will be made by the Carnival Referee and National Surf Sports Officials Advisor.
- b) All officials nominating for appointment should ensure that they are physically capable to carry out their important functions for the duration of the event.
- c) Appointed officials are responsible for the cost of travel and accommodation. Official shirts and hat will be provided at the event for officials to wear.
- d) Immediately after the close of nominations, the appointment of officials will be finalised and a letter of appointment will be issued as soon as possible after selection.
