## **CATERING**

### **Social Functions**

These will be distributed under the direction of the Sectional Referees. At the completion of activities on these days, refreshments will be available at the Officials Briefing Area at Scarborough SLSC.

**NOTE:** SLSA would like to remind all Officials to bring a refillable water bottle that they can refill throughout the Championships with water that will be made available.

### **DRESS OF OFFICIALS**

It is imperative that the appearance of appointed Officials for the 2009 Whereis® Australian Surf Life Saving Championships is of a standard befitting the event (Surf Sports Manual, Manual No 3, 33<sup>rd</sup> Edition September 2008, Clause 13.4).

Therefore, appointed Officials are requested to give detailed attention to their appearance. Dress shall be neat white shorts / skirt **or** optional navy blue shorts / skirt **or** the championships board shorts with the white shirt / championships shirts that is distributed at the event.

**NOTE:** Each Official will be given two Official's shirts which must be worn on the Saturday / Sunday. Officials who are officiating for two days or less will receive ONE Official's shirt.

**NOTE:** Only plain white or the 2009 Official's shirts are permitted to be worn at the 2009 Whereis® Australian Surf Life Saving Championships.

For 2009 each Official will receive a Hawaiian dress shirt. A hat and sponsor spray jacket will also be provided.

**NOTE:** No sponsor or other identification other than the SLSA logo is permitted on any Officials clothing, hats, etc. Notwithstanding the foregoing, sponsored shirts etc, maybe made available for issue to carnival Officials who will be expected to wear these garments generally, Saturday and Sunday in particular.

### **MULTIPLE DUTIES OF OFFICIALS**

Depending on resource needs some Officials may be requested to work in positions or areas other than those listed in this circular. Such Officials will be advised during the course of competition.

Any official from areas finishing early and not otherwise advised, should contact Gordon McNaughton in the Administration Areas for listing for further allocation if required.

### **APPOINTMENTS**

The appointment of Officials is a consultative process involving the Director of Surf Sports, the Carnival Referee and the Competition Officials Advisor, and when appointed the Area Referees are included in the final consultation. All appointments emanate from nominations received and endorsed by the respective States and National bodies. These appointments are based upon Official's competencies as assessed periodically.

### **HEALTH AND FITNESS OF OFFICIALS**

Each and every appointed Official is encouraged to prepare for these Championships by ensuring that they are in a physical condition that will allow them to work in prevailing conditions in a comfortable manner. It cannot be over-stressed that to officiate at these particular Australian Championships over the 5-6 day period, requires quite an amount of physical and mental effort.

Further, each Official is strongly encouraged to undertake a health check with their Medical Practitioner, to ensure their physical condition is of a level that will allow them to carry out their appointed duties.

After advice received from the Cancer Council, it is stressed that all Officials be adequately protected from the sun to avoid over exposure. The wearing of appropriate Official's clothing and the wide-brim hats provided, plus the regular application of recognised sun protection creams and lotions is strongly advised.



### **NAME BADGES**

All Officials are advised that it is essential that they bring their national Officials accredited name badges and license. Additional to this, each Official will be issued with an official identification tag.

### **REFEREE'S CLOTHING**

Area and Sectional Referees will be supplied with either coloured shirts or coloured bibs. This will allow all Area and Sectional Referees to be identified to their position.

### **COLLECTION OF OFFICIALS KIT**

Each appointed Officials must present themselves at the Officials Briefing Area at Scarborough SLSC to collect their Officials Kit between the following times:
