## **Call for Nominations - National R&R Advisory Panel**

### **Summary**

Nominations are now being called for the National R&R Advisory Panel. Nominations close 5pm Thursday 29<sup>th</sup> October 2009.

### **1. Summary**

The National R&R Advisory Panel was established in January 2008, reporting into the Board of Surf Sports (BOSS). A representative from each state will sit on this panel with a chairperson elected from this group, along with a secretary and a representative from the Athletes Commission. The Chairman will be elected by the delegates at its first meeting. The panel meets face to face once a year and holds teleconferences when necessary.

The panel is required to:

- Measure the trends of participation in R & R;
- Recommend strategies to improve the event's growth;
- Identify opportunities for the event to develop;
- Define target figures for all age category growth a over three year period;
- Review R&R Coaching numbers across each state
- Develop a coaching recruitment plan and marketing plan to increase participation in R&R

The business of the R&R Advisory Panel will flow to and from the BOSS. The panel is *not* responsible for technical matters relating to R&R competition as this will be the responsibility of the Technical Committee.



## **2. Job Specifications**

### **2.1 Qualifications**

Shall be a member of SLSA with a sound knowledge in the field of R&R and Sport Development

### **2.2 General Responsibility**

- a. Be responsible for the overall development of R&R as indicated above.
- b. Encourage members, groups and teams to realise their potential and athletic abilities
- c. Appoint relevant project teams as sub committees to assist the BOSS to fulfill its obligations.
- d. Attend to matters referred by the Board of Surf Sports
- e. Review R&R performance continually and report to the Board of Surf Sports

### **2.3 Term of Appointment**

Each member of the panel will be appointed for a period of 2 years.
